4. **OBJECTS** The objects for which the Trust is founded are:



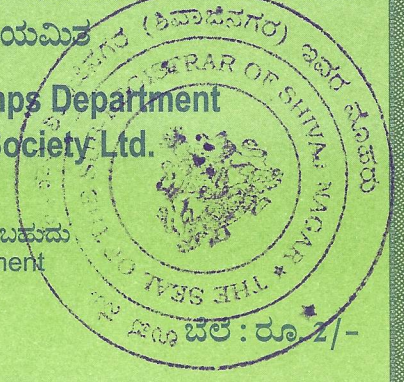

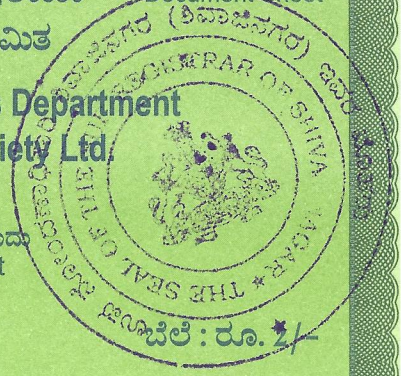

5. NUMBER OF TRUSTEES:

The number of Trustees including the Authors of the Trust shall not be less than 3 (three) and not more than 9 (nine) persons. The Board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper.

6. TERM OF OFFICE OF THE TRUSTEES:

These Trustees shall hold office for such duration as may be specified by the President

7. PRESIDENT:

Dr. Sudhir Dinakaran Kartha shall be president for lifetime. And only legal heirs are eligible to become president. All the decision shall be taken by president is final. He shall nominate managing trustee and trustees and the term of the managing trustee and trustees shall be decided by president. At any time he shall remove managing trustee or trustees and his decision is final. He shall advise the managing trustee and trustees to maintain all the records of the trust.

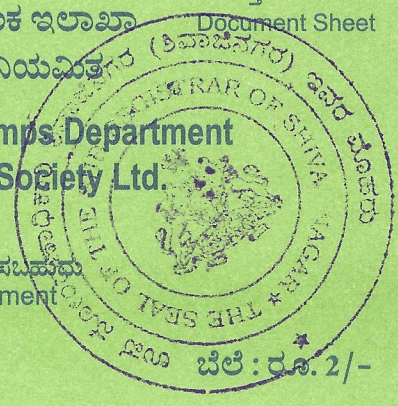

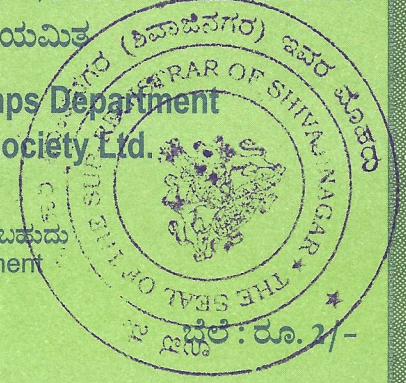

14 days Notice shall ordinarily be given in writing for a meeting of Board of Trustees.

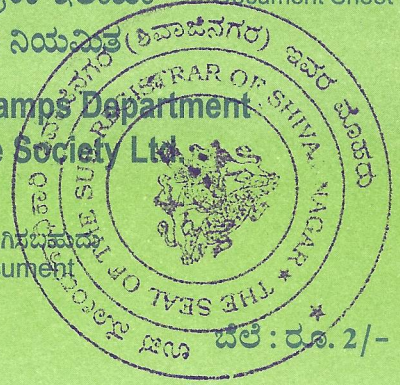

15. QUORUM:
