The school shall admit in class I, to the extent of 25% of the strength of the class, children belonging to weaker sections and disadvantaged groups in the neighborhood and provide free and compulsory education till completion of elementary education. provided that if the school admits children in Pre -primary classes also, the school shall follow the norms. The children so admitted shall not be discriminated from the rest of the children or segregated or treated separately in any manner.


